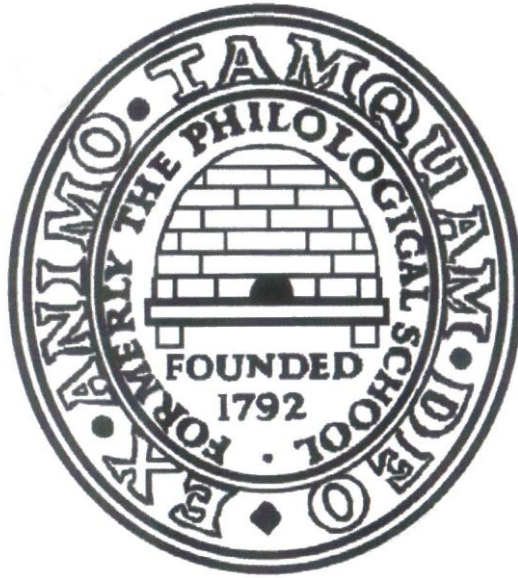

**Notes to be read in conjunction with Accounts for the
Year ending 31 December 2017**

1. Since 2004 the Association received generous donations totalling £3,000 from Mrs Clara Waters to fund an annual toast at the dinner in memory of her husband, Basil. The balance brought forward to 2017 was £311.80. Port at RAF Club Dinner in 2016 was £134.90.
The balance carried forward to 2018 is £176.90.
2. £100 invested in 31/2% War Stock 1929-47. The interest received stopped in 2015 as the government bought back the Stock. Our investment was traced in 2017 and we received the investment back into our current account.
3. Stock of ties - 19 (Selling Price £12 each — stock total £228.00); bow ties - 6 (Selling Price £15 each — stock total £90.00).
4. During 2008, the Association produced Greetings Cards featuring two watercolours by H W Llewellyn-Smith, and reproduced by kind permission of Mr C Bosley. The cost of production was £589.85 and sales to end of 2017 total £740.00. 6 packs are held in stock (only Mill cards left) with a selling price of £5 each — stock total £30.

Committee Report

I will be briefer than usual with this year's but nothing omitted I hope.

The AGM was held on 5th April 2017 at 248 Marylebone Road by kind permission of Abercorn School. The usual attendance of about twenty with over thirty apologies for absence. It would be more encouraging for the Committee if more members could manage to attend future AGM's. All post holders were re-elected. The AGM Minutes for 2016 were approved and signed.

I attended Abercorn School's annual prize-giving held on 23rd June at the Landmark Hotel adjacent to Marylebone Station.

The Annual Pilgrimage to Forest Green (now 37th) on 10th September saw about 40 attending. Memories of school were re-lived over a barbecue lunch and a glass or two of wine.

The Annual Dinner on 25th October at our now usual venue the RAF Club in Piccadilly attracted fewer members than in previous years — somewhat disappointing to the organizers. It was chaired by our President Sir Brian Vickers and the Speaker was Judith Geldard. The "Daily Telegraph" reported it next day.

Gerald Margolis and I continue as Trustees of the Philological Foundation working in Camden and Westminster.

The Secretary and I attended the funeral of Dr Harry Westbury in January 2018 at Ruislip crematorium.

I am pleased to announce that Edmund May (SMGS 1963 —70) has taken over from Richard Durran as Webmaster and Newsletter editor. Ed was co-opted onto the Committee at its spring meeting. We are grateful to him and of course to Richard for all his hard work over the many years.

At this year's AGM the Secretary will have told of several proposed amendments to the Association's Rules.

Finally, I urge all members to try to be more supportive of meetings to encourage all the committee members all of whom work hard to sustain our flourishing association. The membership is still strong but needs expansion. Long may it continue.
